IN FY'22, THE QUEENS BOROUGH PUBLIC LIBRARY OFFERED FREE ACCESS TO A COLLECTION OF MORE THAN 5 MILLION BOOKS AND OTHER MATERIALS IN MULTIPLE LANGUAGES, WHICH CIRCULATED 6.7 MILLION TIMES. THE LIBRARY HAD OVER 3.9 MILLION VISITS AT ITS 66 LOCATIONS ACROSS THE BOROUGH. MORE THAN 961,000 THOUSAND PEOPLE USED THE LIBRARY'S COMPUTERS AND ACCESSED THE WI-FI NETWORK. THE LIBRARY OFFERED OVER 28,700 EDUCATIONAL, CULTURAL, RECREATIONAL, AND CIVIC PROGRAMS WITH AN ATTENDANCE OF MORE THAN 540,600 CUSTOMERS.
