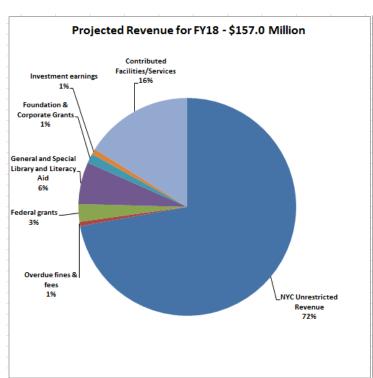

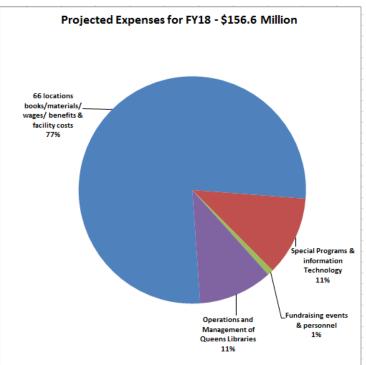

#### Notes on the Proposed Budget for FY 2018

- FY 2018 proposed revenue shown on the chart is based in part on New York City's January Plan for FY 2018. The City's budget is subject to change. Under the proposed budget here, the City would provide 88% of the total FY 2018 revenue.
- In addition to the revenue disclosed in the FY 2018 January Plan of \$102.4 million, Queens Library has requested operating funds of \$1.0 million for Hunters Point Library pro-rated to account for projected opening date and an additional \$9.75 million for seven-day service at 14 libraries and expanding program, translation and technology services for our customers. The \$9.75 million is part of a \$34 million increase that is being requested to fund libraries across the five boroughs.
- New York State has recently finalized its budget for the fiscal year and we project that funding from NYS will be consistent with amounts received in FY 2017.
- All grants are subject to submission of an application, most of which are competitive. Some government grants provide funding for more than a one-year term. Other grants must be renewed annually and there is no assurance these grants will be renewed. These grants have been included in our projections unless information has been communicated that the grant will not be available after the expiration of the current term.
