## 4. Anti-Racism, Diversity, Equity, & Inclusion (ADEI) Presentation W/ UPD Consulting, LLC (ID # 2797)

Sharon Myrie, VP of Programs and Services, introduced Philip Jacobs, Senior Consultant and Elaine Farber Budish, Director of UPD Consulting, LLC to the board. Mr. Jacobs and Ms. Budish gave the board a presentation and update on the status of the Anti-Racism, Diversity, Equity, and Inclusion (ADEI) project. Ms. Myrie reported that this ADEI initiative was funded through a portion of a grant received by the Robin Hood Foundation to support the work of the President's Council on Racial Equity (PCRE), which was formed in August 2020. This initiative will assist in identifying racial barriers that may have a negative impact on Black employees and customer, and suggest corrective measures for change. Mr. Jacobs and Ms. Budish reported on the findings from the surveys, focus groups and meetings, as well as statistical analysis gathered. Mr. Jacobs gave the board a projected timeline of the project. UPD Consulting is currently in the synthesizing phase of data gathered to date. With PCRE's assistance, the final phase will include developing a Playbook that will include an action plan to implement the prioritized recommendations from the collected data. Vice Chair of Board, Earl Simons, Ed.D, asked Mr. Jacobs for his recommendations on how the board can demonstrate to Black

staff and customers that their concerns are being heard. Mr. Jacobs responded that the board's presence, as well as continuing to be actively involved within the Library, is important. He stated that the data collected indicates that many staff are not aware of the Library's board members. He also indicated that staff would like to be acknowledged, valued, and included. He also indicated that communication is important to ensure that Library staff and customers are aware of what is happening within the Library. Dennis M. Walcott, President and CEO, thanked UPD Consulting, LLC, and the PCRE for all the teamwork and progress with this project. Prior to the next motion, trustee Matthew Gorton requested an update in January concerning the QPL-QLF Operating Agreement.
